**Re: CAMH re: Ken Zucker and Lynn Conway
File No. 300566**

We are the lawyers for the Centre for Addiction and Mental Health ("CAMH") and Dr. Kenneth Zucker. We understand that you are the founder and president of Organisation Internationale des Intersexues ("OII").

We are writing to you with respect to certain statements found on your website at <http://www.intersexualite.org/WPATH.html>, and titled "Open Letter to the President of WPATH from OII - (Sent 28 May 2008)." Dr. Zucker is particularly concerned about the false, and frankly outrageously irresponsible, statements alleging he was involved in, or guilty of, sexually abusing one of his patients.

We understand that you have also written to the Executive Board of the American Psychological Association advising that you received a communication from a "Noriko Matsuyama" who alleges that Dr. Zucker and his assistant sexually abused her when she was a child patient at the Clarke Institute.

Dr. Zucker emphatically denies these and any other allegations of sexual abuse. Furthermore, he has never treated anyone named "Noriko Matsuyama".

As we have stated many times previously, our clients do not object to your continued criticisms of Dr. Zucker's opinions and methods and the work of the Gender Identity Clinic. Our clients understand that their theories and


work are at the centre of vigorous debate. However, our clients are deeply concerned about the continued dissemination of untrue allegations that Dr. Zucker has engaged in criminal conduct.

Our clients are not trying to intimidate you or your organization and strongly deny any allegation that they are trying to stifle free speech. Our clients, however, cannot allow the false allegation of sexual abuse involving an alleged former child patient, to be disseminated without a response.

Your allegations referred to above concerning Dr. Zucker are false and completely without any foundation whatsoever. Unless your tactic is to try and discredit Dr. Zucker by continuing to disseminate these blatant falsehoods because you have no better argument to make, we expect you to remove these allegations.

Again, our clients do not seek to discourage comment and debate. However, they draw the line at false and irresponsible allegations of serious criminal conduct.
